2008 – 2011 (Extreme 12% Risk Level)

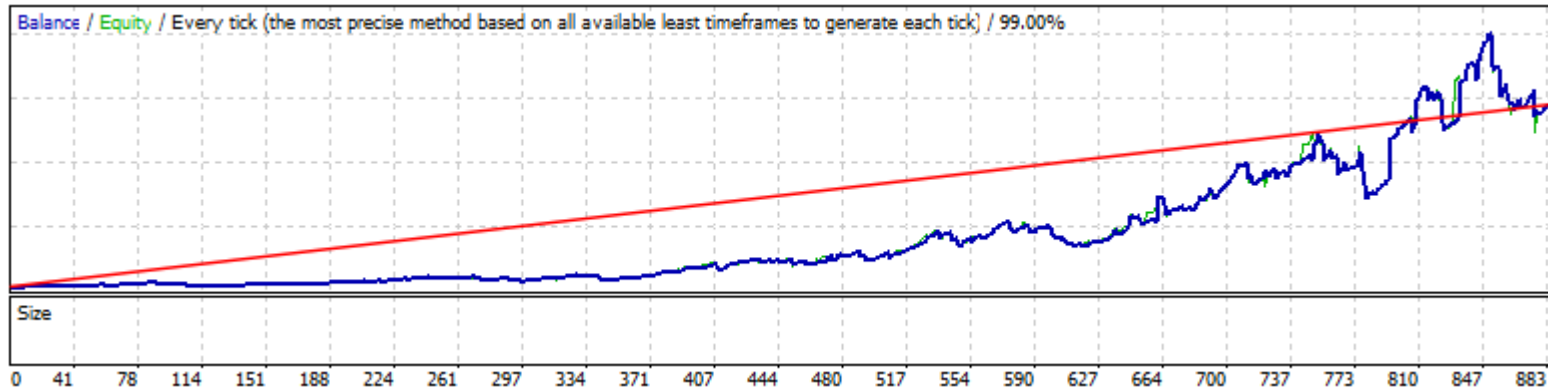
